Notes for WILLIAM DANIEL FISHER:

Before his marriage, he had a cleaning and barber shop in Jenningsston, which became a ghost town when the lumber industry moved away. Jenningsston was located on the Dry Fork Railroad which connected Hendricks and Harman.

After he married Bessie Moore Fisher, he joined his father in law in operating Moore & Co. until the depression forced him to seek other employment. For a time, he was the sign foreman for WVDON, District 8. He then leased properties in WV and surrounding states for various oil & gas companies. He was on a special assignment in Pochantas County when he succumbed to a heart attack and died in Marlinton, WV.
