Entered Winchester College at age 11, being admitted in 1590. He was a Fellow of New College in 1598, won his B.C.L. Feb 7, 1604, won his D.C.L. June 21, 1610, was made an Advocate Doctors Commons in 1611. He was a Master in Chancery about 1618, and was made a Judge of the Faculties & Perogative Court in Ireland. He was appointed Advocate General to King Charles I and knighted on March 9, 1644. He died January 2, 1651 and was buried at St. Clement Danes.

William was 16 when he was imported by a Littleton Scarburg into Surry County, Virginia (possibly that William was arrested because of his participation in the revolt). By 1664, William had paid his indenture and began to appear in county records as a freeman. No will or settlement papers have been found. Not possible to identify any daughters.

Family legend has it that "during the early years of English settlement in the New World, it is said, three brothers Reeves came from England to the colonies. They settled, respectively, in New York, Virginia, and South Carolina, each becoming, so the account goes, a man of prominence in his community." Perhaps William is the brother who settled in Virginia.

Asa is listed in the DAR Patriot Index - Centennial Edition. Dates of birth, death, and wife all match. He is listed as "PS VA" (private soldier Virginia?). This means, of course, the he fought in the Revolutionary War.

One researcher writes: " Asa was a Virginia patriot, furnishing supplies for the revolution, namely 225 pounds of beef, four horses, four wagons, and drivers for the same."

Asa's will reads (Fleming County Clerk's Office, Flemingsburg, KY. Will Book C. page 106-7:

"In the name of God Amen. I Asa Reeves of Fleming County and State of Kentucky being weak in body but of sound and perfect mind and memory considering the uncertainty of this mortal life do make and publish this my last will and testament in the manner and form following that is to say. First it is my will and desire that all my just debts be speedily and punctually paid. Item I give and bequeath to William Reeves one hundred acres of land lying in Fleming County and State aforesaid being part of the tract of land I now live on it being the land that I gave the said William Reeves the privilege of selling which he has done. Item I give to Elias Reeves one hundred acres of land being part of the tract that I now live on which I gave him the privilege to sell and he has sold it. Item I give and bequeath to Jabes Reeves one hundred acres of land being part of the tract of land I now live on which I have made a deed of gift which will show the boundaries of said land. Item I give and bequeath to Asa Reeves one hundred acres of land being the place the I purchased of my son Wm. Reeves and is part of that I now live on. Item It is my will and secure that the balance of my land be equally divided between George Reeves and Isaac Reeves and that Isaac Reeves' part is to be laid off so as to include the buildings and orchard where I now live. Item All the remainder of my Estate it is

my will and desire that it be equally divided amongst my six daughters Ann Doggett Crooke, Susannah Reeves, Sally Collingsworth Mahan, Elizabeth Jones, Margaret Burk, Jane Carter, and my adopted son Benjamin Reeves.

I appoint my son George Reeves Executor to this my last will and testament hereby revoking all former wills by me made. In witness whereof I have hereunto set my hand and seal the seventh day of July one thousand and eight hundred and nineteen.

At a court held for Fleming County on the 3rd day of November 1823:

This writing purporting to be the last will and testament of Asa Reeves, Snr. dec'd. and was produced in court proven by the oaths of Thomas Summers and James Blair and ordered to be recorded which is done.

After quoting the will above, one writer continues:

"One story has it that Asa owned 7000 acres in Fleming County. If this is an accurate figure, one is left with the feeling that non of the children except George and Isaac were held in particularly high regard by their father, although no doubt a court record is little indication of the peculiar configuration of family loyalties, needs, and prior favors that determine the final disposition of one's earthly property. One is particularly "struck", however, with the discovery that all land and buildings were given to the male heirs, while daughters inherited only Asa's other (and, one would presume, less valuable) possessions. One might have speculated, of course, that women's inheritances were handled as part of a dowry tradition, except that the daughter Susannah appears not to have married prior to Asa's death. Finally, we note that despite the family's "adoption" of Benjamin, he appears to be less than a "full-fledged" male in the line of inheritance, and we can only guess as to his role in the family scheme of things."

But yet we find a marriage record for Susannah dated November 6, 1790, in Fleming County, Kentucky.

Notes for ELIAS REEVES:

The "Elias" mentioned in Asa's will is almost certainly, one would assume, the son usually identified as Eli. Eli was probably born sometime during the 1760's, and served in the Revolutionary War, before the move West to Kentucky, where, as one account goes, in Mason county around 1790, he met Sarah J. Redmond (or perhaps Redman), also of Virginia birth. Sarah, born in 1772, had early in life moved with her parents, Daniel and Sarah, to Kentucky. According to this version of the family history Eli and Sara were married January 28, 1791. About 1803 Eli and his family moved to Brown County, Ohio, of which, according to the record, "he was one of the earliest pioneers."

A second report indicates the Eli had already moved to Ohio when he met Sarah Redmond, who was herself an Ohio native. Whichever way the story goes, however, it seems certain that the Reeves lived in Brown County for many years, through the births of several children - Elijah, being born there on August 11, 1814. In all Eli and Sarah were to have 13 children: Iley (or Ila), Daniel, Eli, Mary A., Sarah, Asa, Anna, John, Neville, Benjamin, Susannah, Elijah, and Jabez.

We read in an "official" history, "By reason of his service as a soldier," Eli received a military claim, "but failing in some way to lay it properly, lost the title to his land and was obliged to purchase another place from the government. He took an active part in the early history of Brown County, cleared a good farm and became a worthy citizen of the community, which he assisted to establish and in which he spent the remainder of his life....dying there on May 21, 1825."
