The petition of Harry Robert Myers and Mary Viola Myers, his wife, respectfully represents unto Your Honor:

1. That your petitioners are residents of Baltimore City, State of Maryland; that they are married and possessed of means sufficient to maintain and rear a child.
2. That the said Robert Anderson was born August 19, 1940, in the city of Baltimore, State of Maryland; that he is the illegitimate child of Viola Yolanda Anderson, who at the time of the birth of the child, was married to Bengt Emanuel Anderson; that the said Viola Yolanda Anderson and Bengt Emanuel Anderson were married May 22, 1940, and that the said Bengt Emanuel Anderson has never recognized the said infant as his child.
3. That the said infant has been in the home of your petitioners since March, 1941; that since the said infant has been in the home of your petitioners, such a feeling of mutual affection has sprung up between your petitioners and said infant that they are desirous of adopting said infant as their own and believe and aver that the best interests of the said infant will be promoted thereby.
4. That the consent of the mother of the said infant and the said Bengt Emanuel Anderson are attached hereto.
5. That your petitioners desire to have said infant's name changed from Robert Anderson to Guy Grant Myers.

ORDER

Upon the foregoing petition and affidavit, it is this 6th day of May, 1942, by the Circuit Court of Baltimore City, ADJUDGED, ORDERED, AND DECREED that the said infant, Robert Anderson, mentioned in these proceedings, be and he is hereby decreed to be legally adopted child of Harry Robert Myers and Mary Viola Myers, his wife as prayed in said petition.

IT IS FURTHER ADJUDGED, ORDERED, AND DECREED that the name of the said infant be and it is hereby changed from Robert Anderson to Guy Grant Myers, and that the said petitioners pay the costs of the proceedings to be taxed by the clerk.
